



With only three healthy wrestlers representing Perkins County, the Plainsmen finished eighth out of 16 teams at the Mullen Invite on Saturday, Jan. 19, scoring 49 points.

Other teams and scores were Plainview 163, Hershey 92, High Plains 91, Hay Springs 82, Sandhills-Thedford 69.5, Sumner Eddyville Miller 60, Mullen 53, Elm Creek 43, Garden County 41, Anselmo-Merna 42, Elwood 32.5, Hyannis 24, Overton 14, Sioux County 18, Red Cloud SD 2.

On opposite ends of the scale, Austin Thelander took the first place medal in the 106 lb. division; and heavyweight Vinny Ross walked away with the first place title in his weight class.
